Following are the Wyoming Department of Agriculture's (WDA) comments pertaining to U.S. Fish and Wildlife Service (Service) proposing to issue Enhancement of Survival Permit (EOS permits) Applications under the Greater Sage-grouse Umbrella Candidate Conservation Agreement (CCAA) with Assurances for Wyoming Ranch Management.
